**MOTION TO SUSPEND TARIFF SHEETS**

**COMES NOW** the Staff of the Missouri Public Service Commission and for its *Motion to Suspend Tariff Sheets* ("Motion") respectfully states as follows:

1. On August 30, 2019, Spire Missouri Inc. d/b/a Spire ("Company") filed revised tariff sheets, P.S.C. MO. No. 7 Second Revised Sheet No. 13.2 Cancelling P.S.C. MO. No. 7 First Revised Sheet No. 13.2 (JG-2020-0043 Spire East) and P.S.C. MO. No. 8 Second Revised Sheet No. 13.2 Cancelling P.S.C. MO. No. 8 First Revised Sheet No. 13.2 (JG-2020-0044 Spire West) in regard to the Company's October 1, 2019 WNAR rate adjustment. These revised tariff sheets have an issue date of August 30, 2019, and an effective date of October 1, 2019, as reflected by Sheet No. 13.2 in both tariff books.

2. The Company's revised tariff sheet filings are intended to reflect the October adjustment made pursuant to the Company's WNAR for the six month period ending July 31, 2019 as provided by Sheet Nos. 13 through 13.2 of both of the Company's tariff books.

3. Staff moves the Commission to suspend both tariff sheet filings and create a docketed case so that Staff may have an opportunity to review the WNAR adjustment calculations for both Spire East and Spire West. Staff intends to complete its recommendation to allow the requested October 1, 2019 effective date.

**WHEREFORE**, for the reasons stated above, Staff respectfully requests that the Commission issue an order suspending the Company's revised tariff sheets P.S.C. MO. No. 7 Second Revised Sheet No. 13.2 Cancelling P.S.C. MO. No. 7 First Revised Sheet No. 13.2 (JG-2020-0043 Spire East) and P.S.C. MO. No. 8 Second Revised Sheet No. 13.2 Cancelling P.S.C. MO. No. 8 First Revised Sheet No. 13.2 (JG-2020-0044 Spire West).
