## **ORDER SHORTENING TIME FOR OBJECTIONS**

Issue Date: September 9, 2021 Effective Date: September 9, 2021 On September 8, 2021, Spire Missouri Inc. d/b/a Spire filed a motion requesting to amend the Partial Stipulation and Agreement that was filed on July 30, 2021. The submission of the amendment was nonunanimous.

In order to resolve the issues addressed by the stipulation prior to the submission of reply briefs on September 17, 2021, the Commission finds good cause for a variance from Commission Rule 20 CSR 4240-2.115(2)(B), which gives the parties seven days to file objections to the amended nonunanimous stipulation and agreement.<sup>1</sup> The Commission will shorten the timeframe to file objections, and direct that any objections to the amended stipulation and agreement be filed on or before September 13, 2021.

## THE COMMISSION ORDERS THAT:

1. Any objections to the amended stipulation and agreement shall be filed on or before September 13, 2021.

2. This order shall become effective when issued.
