## STAFF RECOMMENDATION

**COMES NOW** the Staff of the Missouri Public Service Commission (Staff), by and through counsel, and submits its Recommendation as follows:

1. On July 12, 2022, pursuant to 20 CSR 4240-28.011(2), Magna5 LLC (“Company”) submitted a letter advising it changed its business name to RingSquared Telecom LLC. The Company indicated it would be using the new RingSquared LLC name for its basic local exchange, non-switched local exchange and interexchange telecommunication services. The Company was certificated by the Commission to provide these services pursuant to case numbers XA-2016-0111 and CA-2018-0157.

2. On July 14, 2022, Company supplemented its notice by stating the effective date of the name change will be immediate upon approval of the Commission and the Company's contact information has been updated in the Electronic Filing and Information System ("EFIS"). The Company provided copies of its name change documents with the Missouri Secretary of State and Delaware Secretary of State.

3. On July 14, 2022, the Commission Ordered Staff to file its recommendation regarding Magna5 LLC's request by July 29, 2022.

4. 20 CSR 4240-28.011(2) states in relevant part:

(2) Any company with a certificate or registration that changes its name shall provide advance notice to the commission of the name change.

(A) Notice may be in the form of a letter signed by company official submitted into Electronic Filing and Information

System (EFIS) as a new case submission containing the following information:

1. The new name of the company and date the new name takes effect;
2. Documentation that the new name is registered with the Missouri Secretary of State; and
3. A statement the company has reviewed and, if necessary, updated the company's contacts in EFIS.

(B) If the company maintains a tariff, then the letter must be accompanied by either a tariff filing that replaces the existing tariff in its entirety or a one- (1-) page adoption notice of the existing tariff.

5. In lieu of a Memorandum, Staff hereby states: the Company has filed all the requisite documentation, including the adoption notice, registration notice with the Missouri Secretary of State; and that the Company has complied with all other aspects of the rules set forth in 20 CSR 4240-28.011(2). No entities have intervened to oppose the name change. There are no tariffs in this matter. The Company is not delinquent in any required filings with the Commission.

**WHEREFORE**, Staff recommends the Commission recognize the name change of Magna5 LLC to RingSquared Telecom LLC and grant such other and further relief as the Commission finds appropriate under the circumstances.
