**REQUEST OF TELEGLOBE USA INC. TO EXTEND
THE FILING DATE FOR ITS ANNUAL REPORT AND
TO FILE CERTAIN INFORMATION CONTAINED
THEREIN UNDER SEAL**

COMES NOW Teleglobe USA Inc. ("Teleglobe"), by and through its attorneys, and, pursuant to 4 CSR 240-10.080(7)&(8), respectfully requests the Missouri Public Service Commission ("Commission") to: (1) extend the filing date for its Annual Report, and (2) allow Teleglobe to file certain confidential information contained therein under seal. In support of its request, Teleglobe states as follows:

1. Teleglobe is a certificated interexchange carrier in Missouri with its principal place of business located at 11480 Commerce Park Drive, Reston, Virginia 20191.

2. As a telecommunications utility subject to the jurisdiction of the Commission, Teleglobe is required to file annual reports with the Commission each year by April 15, on a form provided by the Commission or on a computer generated replica which is acceptable to the Commission (4 CSR 240-10.080(1)&(4)).


3. Teleglobe timely filed its 1999 Annual Report with the Commission on April 10, 2000. However, said Report was promptly returned to Teleglobe due to the format of the financial

information provided. As a result, Teleglobe must now respectfully request an extension of time to today, to file its attached Annual Report for the year ending December 31, 1999.

4. Teleglobe respectfully requests the proprietary treatment of certain confidential financial information contained in its attached Annual Report, since the release of this nonpublic information potentially could harm Teleglobe's competitive interests. Accordingly, Teleglobe is submitting with this Request a proprietary version of the Annual Report which is being filed under seal, and a public redacted version which may be filed as a matter of public record.

WHEREFORE, Teleglobe USA Inc. respectfully requests, pursuant to 4 CSR 240-10.080 (7) & (8), that the Commission grant its request for an extension of time to this date for filing its Annual Report, and further grant its request that confidential information contained therein be filed and maintained under seal.
