## MOTION TO SUSPEND FILING OF THE PROPOSED PROCEDURAL SCHEDULE

COMES NOW the Staff of the Missouri Public Service Commission (Staff) and for this Motion to Suspend states as follows:

- 1. Southwestern Bell Communications, Inc. d/b/a Southwestern Bell Long Distance filed an application on August 4, 1998, for a certificate of service authority to provide interexchange telecommunications service in the State of Missouri.
- 2. The Commission issued an order on September 9, 1998, granting intervention to Mid-Missouri Group, Sprint Communications Company L.P., MCI Telecommunications Corporation, McLeodUSA Telecommunications Services, Inc., AT&T Communications of the Southwest, Inc., CompTel-Mo, and Digital Teleport, Inc.. Participation without intervention was granted to Fidelity Telephone Company and Small Telephone Company Group. The Commission ordered the parties to submit a proposed procedural schedule no later than October 9, 1998.
- 3. The parties met in a pre-hearing conference on October 6, 1998. The parties agree that the date for submitting the proposed procedural schedule should be suspended while the parties negotiate a stipulation. The parties request that the Commission suspend the filing of a proposed procedural schedule until November 6, 1998.

WHEREFORE, the Staff respectfully requests that the Commission suspend the filing of a proposed procedural schedule until November 6, 1998.
