### MOTION TO ESTABLISH PROCEDURAL SCHEDULE

1. Upon receipt and review of this Order, the undersigned sent a letter dated July 6 to all attorneys of record, a copy of which is attached, proposing a specific Procedural Schedule. In response thereto, the undersigned was contacted by the counsel for Southwestern Bell Wireless, Southwestern Bell Telephone, counsel for the Small Telephone Company Group, and counsel for Staff.
