**MOTION FOR CLARIFICATION OR AMENDMENT**

COME NOW Northeast Missouri Rural Telephone Company (“NEMR” or Company) and NEMR’s wholly owned subsidiary Northeast Missouri Long Distance, L.L.C. (“NELD”)(together “the Companies”) and for their request for clarification or amendment, state to the Missouri Public Service Commission (“Commission”) as follows:

1. On December 1, 2012, the Commission issued its Order Concerning Election of Waiver which granted the Companies’ request for expedited treatment and acknowledged the Companies’ notice of election of waiver of 4 CSR 240-33.150.

2. The Companies’ Application also requested that the Commission’s order: (a) recognize the transfer of the IXC certificate to NEMR effective as of January 1, 2012; and (b) approve NEMR’s adoption of the NELD tariffs effective as of January 1, 2012.

3. This Commission granted similar relief in Case No. TE-2011-0158 in its Order Granting Waiver, Transfer of Certificate and Adoption of Tariff, issued December 17, 2010. (See Attachment A, Ordered Paragraphs No. 2 and 3). The Companies request that the Commission amend or clarify its order by adding ordered paragraphs similar to Case No. TE-2011-0158.

WHEREFORE, the Company hereby requests that the Commission issue an amended order or clarification that recognizes the transfer of the IXC certificate to NEMR as of January 1, 2012 and approves NEMR’s adoption of NELD tariffs effective January 1, 2012.
