ORDER GRANTING LEAVE TO FILE ANNUAL REPORT OUT OF TIME

Pursuant to 4 CSR 240-10.080(1), "[a]ll public utilities subject to the jurisdiction of the Missouri Public Service Commission shall file an annual report with the commission on or before April 15 of each year."

On June 15, 2000, TransWorld Network Corp. (TransWorld), filed a motion with the Commission requesting permission to file its 1999 annual report out of time. TransWorld included its 1999 annual report with its motion. TransWorld stated in its motion that it was unable to file its report on time because its President was unavailable in mid-April to verify the annual report. No objections to TransWorld's motion were received.

The Commission finds that good cause exists to permit filing of TransWorld's annual report out of time, and the Commission will grant TransWorld's motion for leave to file its annual report out of time.

IT IS THEREFORE ORDERED:

1. That TransWorld Network Corp.'s June 15, 2000, motion requesting permission to file its annual report out of time is granted.

2. That the annual report deadline requirement of 4 CSR 240-10.080 is waived and the filing of TransWorld Network Corp.'s annual report on June 15, 2000, is approved.

3. That this order shall become effective on July 7, 2000.

4. That this case may be closed on July 10, 2000.

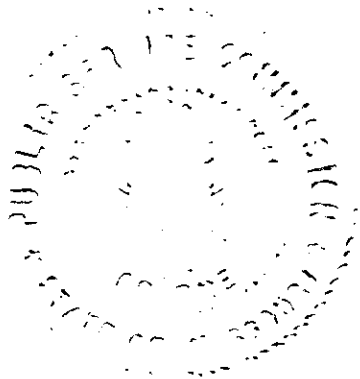
