

MOTION FOR LEAVE TO AMEND APPLICATION

Comes now 2ND CENTURY COMMUNICATIONS, INC. ("2nd Century" or the "Company") and pursuant to 4 CSR 240-2.080(21) moves for leave to amend its application in the referenced matter.

In support thereof, the Company submits the following:

1. Since the time the Company's application was filed in this case, several rules of the Commission have been revised or rescinded and the list of waivers requested by the Company in its application are now out of date. Accordingly, 2nd Century requests leave to amend paragraph 22 of its application by interlineation to reflect the statutes and rules, as they have been revised, for which the Company requests waiver.

2. The Company asks leave to amend paragraph 22 of its Application so that it should hereafter read as follows:

22. 2nd Century is willing to comply with all applicable Commission rules, and is willing to meet all relevant service standards, including but not limited to, billing, quality of service, and tariff filing and maintenance. However, consistent with the Commission's treatment of other certificated competitive local exchange telecommunications companies, 2nd Century requests that the following statutes and regulations be waived for its basic local exchange telecommunications service offerings, in accordance with §392.420, RSMo 1994 and. 4 CSR § 240-32.010(2):




