MOTION TO REOPEN CASE AND TO AMEND CONDITIONAL CERTIFICATE TO REFLECT CHANGE IN MISSOURI CORPORATE NAME

Comes now 2ND CENTURY COMMUNICATIONS, INC., ("2nd Century" or "Company") and for its above entitled motion states the following to the Commission:

- 1. On June 8, 2000, the Commission entered its order approving 2nd Century's application for a certificate of service authority to provide basic telecommunication services in the state of Missouri, on the condition, among others, that it file for Commission approval its tariffs setting forth the rates, terms and conditions upon which it will render service. The Commission's order was clear that 2nd Century's certificate of service authority would become effective when its tariff became effective. The order also stated that the case could be closed on June 20, 2000.
- 2. Although 2nd Century has filed an illustrative tariff for the Commission's consideration, it has not yet filed a tariff with "issued" and "effective" dates. As a result, 2nd Century's certificate is still conditional at this time.
- 3. 2nd Century is a privately-held corporation duly organized and existing under and by virtue of the laws of the State of Delaware. The Company was incorporated on July 14, 1998,

and is headquartered at: 7702 Woodland Center Boulevard Suite 50 Tampa, Florida 33614 (813) 935-8866. The Company acquired its conditional certificate in this case under the name "2nd Century Communications, Inc." The Secretary of State has determined that 2nd Century cannot use this name in Missouri, and has approved for the Company's use the new name of "2nd Century Communications Group, Inc." This is not a fictitious name for the Company. It is now the official corporate name of the company in Missouri. A copy of 2nd Century's current Certificate of Good Standing—Foreign Corporation issued by the Missouri Secretary of State is attached as Exhibit 1.

- 4. By this motion, 2nd Century seeks a Commission order which reopens the case for the purpose of changing the name of the certificate holder from 2nd Century Communications, Inc. to 2nd Century Communications Group, Inc., thus amending the conditional certificate issued herein so that it reflects the proper and official corporate name— as used in Missouri— of the certificate holder.
- 5. Because 2nd Century has not commenced provision of basic local service, no customers will be affected by this change in name. In fact, waiting to change the name after tariff approval, by means of the procedures in 4 CSR 240-2.060(16), would have the potential of causing customer confusion, which will be avoided if the name is amended at this time.
- 6. 2nd Century has filed on even date with this motion a proposed tariff bearing a forty-five (45) day effective date, and the tariff has been issued under the name "2nd Century Communications Group, Inc., in anticipation of a favorable ruling on this motion, and in the interest of time.

WHEREFORE, 2nd Century respectfully requests the Commission to reopen this case strictly for the purpose of permitting an amendment to the conditional certificate reflecting a change in the name of the certificate holder from 2nd Century Communications, Inc. to the 2nd Century

Communications Group, Inc.
