### MOTION TO AMEND PROCEDURAL SCHEDULE

COME NOW Union Electric Company d/b/a Ameren Missouri ("Ameren Missouri" or the "Company"), the Missouri Public Service Commission Staff ("Staff"), and the Office of the Public Counsel ("OPC"), and hereby request a minor amendment to the current procedural schedule and, in support of their request, state as follows:

- The procedural schedule requires rebuttal testimony to be filed on Monday, October
   2018.
- 2. The Charge Ahead proposal in this docket consists of three parts, including changes to the Company's non-residential line extension policies.
- 3. The Movants have reached agreement in principle on the terms of a settlement of the line extension portion of the Charge Ahead filing, but due to certain personnel being unavailable to review certain details (including final tariff sheet language), may not be able to complete the settlement documents by October 1.
- 4. Rather than requiring parties to file rebuttal testimony on the line extension issues when a settlement appears likely in the next couple of business days, Movants request that the deadline for rebuttal testimony on the line extension issue only be extended to Friday, October 5, 2018. The remainder of the ordered procedural schedule would remain as-is.

WHEREFORE, Movants request that the Commission modify the current procedural schedule as requested herein.
