#### MOTION TO AMEND PROCEDURAL SCHEDULE

**COMES NOW** Spire Missouri Inc., d/b/a Spire ("Spire" or "Company"), by and through counsel, files this Motion to Amend Procedural Schedule and in support thereof state as follows:

- 1. On December 11, 2020, Spire Missouri Inc. d/b/a Spire filed a Request for Authority to Implement a General Rate Increase. On February 3, 2021, the Commission issued an Order Setting Procedural Schedule, directing parties to produce the List of Issues, Position Statements, Order of Hearing, and Joint Stipulation of Facts by July 16, 2021.
- 2. The parties discussed the matter, and Spire, Office of the Public Council, Missouri Industrial Energy Consumers, National Housing Trust, Renew Missouri Advocates, Legal Services of Eastern Missouri, Consumers Council of Missouri, Missouri Propane Gas Association, Missouri School Boards' Association, and Vicinity Energy Kansas City, Inc. all support and do not oppose an extension of the deadline for filing of Position Statements<sup>1</sup>.
- 3. To give parties time to review the List of Issues before forming arguments, Spire is requesting an additional business day to file their Position Statements on or before July 19, 2021. In addition, this will allow the parties to continue negotiating settlement of the issues involved in this case.

WHEREFORE, Spire hereby request the Commission grant additional time until July
