Pursuant to 20 CSR 4240-28.011(2), Metro Fibernet, LLC d/b/a respectfully requests that the Missouri Public Service Commission ("Commission") acknowledge its fictitious name change to "Metronet." In its initial CLEC application in File No. LA-2023-0137, as well as its IVoIP Registration application in File No. DA-2022-0045, Metronet inadvertently requested certification and registration, respectively, for "Metro Fibernet, LLC d/b/a MetroNet," when the company's legally registered fictitious name at the Missouri Secretary of State is, in fact, "Metronet." Evidence of the company's fictitious name registration is included as Attachment A.

Metro Fibernet, LLC d/b/a Metronet in good standing with the Missouri Secretary of State. Concurrently with this filing, the company is updating its 2022 Annual Reports to reflect the proper fictitious name. 
