

**REQUEST OF KCI Long Distance, INC.
TO EXTEND THE FILING
DATE FOR ITS ANNUAL REPORT**

COMES NOW KCI Long Distance, Inc. ("KCI"), by and through its attorneys and, pursuant to 4 CSR 240-10.080(8), respectfully requests the Missouri Public Service Commission ("Commission") to extend the filing date for its Annual Report. In support of its request, KCI states as follows:

1. KCI is a certificated interexchange carrier in Missouri with its principal place of business located at One Telergy Parkway, East Syracuse, New York 13057.
2. As a telecommunications utility subject to the jurisdiction of the Commission, KCI is required to file annual reports with the Commission each year by April 15, on a form provided by the Commission or on a computer generated replica which is acceptable to the Commission (4 CSR 240-10.080(1)&(4)).
3. The attached "Annual Report of KCI Long Distance, Inc." for the year ended December 31, 1999" was duly prepared and mailed for filing with the Commission. However, the filing arrived after April 15, 2000, and it was returned. 
