APPLICATION TO INTERVENE

COMES NOW CenturyTel of Missouri, LLC d/b/a CenturyLink ("CenturyTel"), Spectra Communications Group, LLC d/b/a CenturyLink ("Spectra"), and Embarq Missouri Inc., d/b/a CenturyLink ("Embarq") (collectively, "CenturyLink") pursuant to 4 CSR 240-2.075 and the Commission's September 22, 2010 *Order Establishing File to Determine Statewide Average Rate Pursuant to Section 392.245.13, RSMO, Setting Intervention Deadline, and Directing Notice* ("Order"), and for their joint Application to Intervene respectfully state as follows:

1. Spectra is a Delaware limited liability corporation that is duly authorized to do business in the State of Missouri and authorized by the Commission to provide basic local and interexchange telecommunications services. Copies of Spectra's Certificate of Authority to transact business in Missouri from the Missouri Secretary of State were filed in Case No. TM-2000-0182, and are incorporated herein by reference pursuant to 4 CSR 240-2.060(1)(G). Spectra operates in Missouri using the fictitious name of "CenturyLink," pursuant to the registration of fictitious name filed in File No. TN-2010-0092 and incorporated by reference herein pursuant to 4 CSR 240-2.060(1)(G).

In the Matter of the Joint Application of GTE Midwest Incorporated and Spectra Communications Group LLC for Authority to Transfer and Acquire Part of GTE Midwest Incorporated's Franchise, Facilities or System Located in the State of Missouri and for Issuance of Certificate of Service Authority to Spectra Communications Group LLC and for Authority for Spectra Communications Group LLC to Borrow an Amount not to Exceed \$250,000,000 from CenturyTel, Inc., and in Connection Therewith to Execute a Telephone Loan Contract, Promissory Notes, and a Mortgage, Security Agreement and Financing Statement, Case No. TM-2000-0182

- 2. CenturyTel is a Louisiana limited liability corporation that is duly authorized to do business in the State of Missouri and authorized by the Commission to provide basic local and interexchange telecommunications services. Copies of CenturyTel's Certificate of Service Authority to transact business in Missouri from the Missouri Secretary of State were filed in Case No. TM-2002-0232,³ and are incorporated herein by reference pursuant to 4 CSR 240-2.060(1)(G). CenturyTel operates in Missouri using the fictitious name of "CenturyLink," pursuant to the registration of fictitious name filed in File No. TN-2010-0091⁴ and incorporated by reference herein pursuant to 4 CSR 240-2.060(1)(G).
- 3. Embarq is a Missouri corporation that is duly authorized to transact business within the State of Missouri and is authorized by the Commission to provide basic local and interexchange telecommunications services within the state. Embarq was originally incorporated in Missouri in 1929 as The United Telephone Company and a restatement of its certification was received in Case No. TA-88-87. Embarq has received all necessary Commission and Secretary of State's Office approvals for subsequent transfers of control and name changes. Evidence of proper authorization was provided to the Commission in Case No. IO-2006-0086,⁵ the transfer of control from Sprint Nextel Corporation to Embarq Corporation, and Case No. TN-2006-0416,⁶ the name change from Sprint Missouri, Inc. to Embarq Missouri Inc., and are incorporated by

5. This case arose from a filing on September 14, 2010, of a Motion to Open Case

by the Commission's Staff, so as to provide a vehicle for the Commission to determine the

statewide average rate of nonwireless basic local telecommunications services as of August 28,

2010, pursuant to section 392.245.13, RSMo Cum. Supp 2009. By its Order issued on

September 22, 2010, the Commission stated that section 392.245.13 requires the Commission "to

conduct a study to 'determine the weighted, statewide average rate of nonwireless basic local

telecommunications services . . . five years after August 28, 2005," therefore opening this file.

The Commission's September 22, 2010 Order directed that any party wishing to intervene in the

case should file an application to do so no later than October 7, 2010.

6. The Commission should permit CenturyTel, Spectra and Embarg to intervene in

this case pursuant to Commission Rule 4 CSR 240-2.075(4)(A) because CenturyLink's interests

differ from those of the general public. As local exchange telecommunications companies,

Century Tel, Spectra and Embarq are three of the companies that have been ordered to submit to

the Commission's Staff the information referred to in the Commission's Order. No other party to this proceeding will adequately represent or protect CenturyTel, Spectra or Embarq's interests.

7. At this point in time CenturyTel, Spectra and Embarq are unsure of the positions they may take in this proceeding, and currently make this application to intervene for the purpose of monitoring the docket, as well as to receive the appropriate orders and notifications that pertain to the companies' obligation to provide information required in this matter. Whether CenturyLink's interests will require it to be a more active participant and the specific positions it

may take will be determined as the case progresses.

8. CenturyTel, Spectra and Embarq's interventions would be in the public interest, in accordance with Commission Rule 4 CSR 240-2.075(4)(B), as their participation in this case will contribute to the Commission's compliance with the requirements of section 392.245.13, RSMo.

WHEREFORE, CenturyTel of Missouri, LLC d/b/a CenturyLink, Spectra Communications Group, LLC, d/b/a CenturyLink, and Embarq Missouri, Inc. d/b/a CenturyLink respectfully request that the Commission grant this Application to Intervene in this proceeding.
