MOTION FOR EXPEDITED TREATMENT OF TARIFFS

COMES NOW Southern Missouri Gas Company, L.P. ("SMGC" or "Company"), by and through its attorneys, pursuant to 4 CSR 240-2.080(17) and 4 CSR 240-2.065(2), and requests that the Missouri Public Service Commission ("Commission") expedite the approval of its tariffs, for good cause shown, and permit the Company to make effective on December 1, 2000, the tariffs authorized by the Commission to be filed in its Order Approving Stipulation And Agreement issued on November 16, 2000, in this proceeding. In support of this Motion, SMGC respectfully states:

- 1. On November 16, 2000, the Commission issued its Order Approving Stipulation and Agreement in which it authorized SMGC to file tariffs consistent with the Stipulation and Agreement and the sample tariffs attached thereto.
- 2. Simultaneously with the filing of this Motion, SMGC is filing the tariffs authorized by Commission in its Order Approving Stipulation and Agreement. The tariffs are identical to the tariffs attached to the Stipulation and Agreement with an issue date of November 17, 2000, and an effective date of December 17, 2000.
- 3. In order that authorized tariffs may become effective by the commencement of SMGC's December billing cycle, SMGC respectfully requests that the Commission issue its Order

Approving Tariffs and allow the tariffs to go into effect on December 1, 2000. This will permit SMGC to implement the authorized increase in rates in an orderly fashion without the need to prorate the bills. As a result, there will be no negative effect upon the Company's customers or the general public if the Commission acts by the date requested. In addition, the Company is filing this pleading as soon as it could have since the Commission issued its Order Approving Stipulation And Agreement on November 16, 2000.

WHEREFORE, Southern Missouri Gas Company, L.P., respectfully requests that the Commission authorize it tariffs to go into effect on an expedited basis and become effective on December 1, 2000.
