## **MOTION FOR EXPEDITED TREATMENT**

Comes now ABA Net, LLC, ("ABA Net" or "Applicant"), pursuant to 4 CSR 240-2.080(16), and for its Motion for Expedited Treatment, states the following to the Missouri Public Service Commission ("Commission"):

- 1. On January 29, 2007, ABA Net submitted for filing, via the Commission's Electronic Filing and Information System, an Application for Interexchange Certificate of Service Authority (the Application) along with a proposed tariff marked with a 45-day effective date of March 15, 2007.
- 2. ABA Net is a new entrant to the Missouri competitive telecommunications industry and is scheduling its first appearance in the Missouri market pursuant to a business plan that it believes maximizes competitive benefits. This business plan contemplates that ABA Net will be able to provide services to Missouri customers on March 1, 2007 or very soon after that date. If ABA Net's services cannot be provided to customers by March 1, 2007, it projects that its market potential will be adversely affected. Therefore, ABA Net respectfully requests the Commission to expedite its consideration of the Application and approve the tariffs involved, not in the 45 day window established by rule, but by March 1, 2007.
- 3. This motion was not filed simultaneously with the Application because the importance of the March 1, 2007 provisioning date was not brought to counsel's attention until

after the application was filed. This motion has been filed as soon as it could have been

following that advice from ABA Net.

4. Under cover of this motion, ABA Net now submits a new proposed tariff marked

with a March 1, 2007 effective date.

5. Prospective customers of ABA Net will suffer no harm should this application

and tariff submission receive expedited treatment. To the contrary, ABA Net submits that its

quickened entry into the market will be in the public interest and in the interest of its expected

customer base.

WHEREFORE, Applicant respectfully requests that the Commission grant its Motion for

Expedited Treatment and approve the tariffs filed with this pleading effective March 1, 2007.
