NOTICE OF DEFICIENCY AND ORDER DIRECTING FILING

On April 28, 2000, Phone Bank, Inc., d/b/a Phone Banc, Inc. (Phone Banc), filed its application requesting a certificate of service authority to provide basic local telecommunications service in state of Missouri. Commission Rule 4 CSR portions of the 240-2.060(1)(A) requires that, in addition to the legal name of the applicant, the application shall include the street and mailing address of the principal office or place of business of the applicant. The application fails to comply with Commission Rule 4 CSR 240-2.060(1)(A) because it does not specify the street and mailing address of Phone Banc's principal office or place of business. Phone Banc is directed to comply with Commission Rule 4 CSR 240-2.060(1)(A).

The Commission also notes that page 3 of the application requests waiver of 4 CSR 24G-10.020. The Commission assumes that the "G" is a typographical error; however, the Commission directs that Phone Banc clarify or correct this citation.

IT IS THEREFORE ORDERED:

- 1. That Phone Bank, Inc., d/b/a Phone Banc, Inc., shall comply with 4 CSR 240-2.060(1)(A) by amending its application to include the street and mailing address of its principal office or place of business, no later than May 23, 2000.
- 2. That Phone Bank, Inc., d/b/a Phone Banc, Inc., shall clarify or correct, no later than May 23, 2000, the reference to 4 CSR 24G-10.020 which is found on page 3 of the application.
 - 3. That this order shall become effective on May 23, 2000.
