MOTION FOR EXPEDITED TREATMENT

COMES NOW Union Electric Company d/b/a Ameren Missouri ("Ameren Missouri" or "Company") and, pursuant to 4 CSR 240-2.160, submits its Motion for Expedited Treatment and states as follows:

1. Certain parties in this case filed a *Stipulation and Agreement Regarding Ameren Missouri's Keeping Current Program ("Stipulation")* on September 24, 2012.

2. On October 3, 2012, the Missouri Public Service Commission issued an order approving the *Stipulation*.

3. Concurrent with this pleading, the parties are filing a *Stipulation and*

Agreement Amendment Regarding Ameren Missouri's Keeping Current Program ("Stipulation Amendment"). The Stipulation Amendment requests additional time, until March 15, 2013, to develop the revised tariff due to scheduling and other considerations.

4. Ameren Missouri has filed this request for expedited treatment as soon as possible after deciding the change was necessary and after receiving consent from other parties in this matter. The Missouri Department of Natural Resources, Barnes-Jewish Hospital, the Missouri Energy Consumer Group, the Sierra Club, Earth Island Institute d/b/a Renew Missouri, the Natural Resources Defense Council, the International Brotherhood of Electrical Workers Locals 2, 309, 649, 702, 1439, 1455 and the International Union of Operating Engineers Local 148, AFL-CIO have indicated that while they will not sign this *Stipulation Amendment*, they do not oppose it. There will be

no negative effect on the party's customers or the general public in granting this expedited treatment request.

WHEREFORE, Ameren Missouri respectfully requests the Commission issue an order approving the revised Stipulation so that additional time is given, until March 15, 2013, to develop the revised tariff.
