**MOTION FOR EXPEDITED TREATMENT**

COMES NOW Union Electric Company d/b/a AmerenUE (AmerenUE or the Company) and, pursuant to 4 CSR 240-2.160, submits its Motion for Expedited Treatment and states as follows:

1. Concurrent with this filing, AmerenUE submitted a new tariff sheet, Sheet No. 98.7 of Schedule 5, which is the Company's Rider FAC. This tariff was filed with a 30 day effective date, meaning it would become effective July 8, 2010, unless the Missouri Public Service Commission (Commission) takes action to approve the tariff earlier.

2. This sheet was filed in addition to the compliance tariffs which were filed on June 8, 2010. This sheet was added after discussions with the Staff in order to clarify the application of the FPA factor in the Company's Rider FAC.

2. Pursuant to 4 CSR 240-2.080(16), AmerenUE requests the Commission issue an order approving the tariff so that it may be effective on the same date as the compliance tariffs filed on June 8, 2010, which the Company has previously requested be made effective on or after June 18, 2010, but no later than June 21, 2010. The reasons for the request are fully set forth in the *Motion for Expedited Treatment and Approval of*

*Tariff Sheets Filed in Compliance with Commission Report and Order on Less than Thirty Days Notice and for Approval of Depreciation Rates.* The Company will not repeat that detail here, but is requesting expedited treatment for the same reasons. This will have no negative effect on either the Company or its customers because the Missouri Public Service Commission has already determined these rates to be just and reasonable. The Company has filed this request as soon as possible after concluding discussions with the Commission Staff.

WHEREFORE, AmerenUE respectfully requests the Commission issue an order approving the Sheet No. 98.7 so that it is effective on or after June 18, 2010 and no later than June 21, 2010.
