- Cite any provision of law supporting such language over the other party's proposed language, and
- Allege any fact relevant under such law. <sup>6</sup>

Further, by separate order, the arbitrator will set forth specific issues for the parties to address in the revised statement of unresolved issues.

The pre-filing of direct testimony, rebuttal testimony and stipulated facts shall not preclude the arbitrator from convening an evidentiary hearing on any issue.

## THE COMMISSION ORDERS THAT:

- 1. The procedural schedule, and items listed in such schedule, shall be subject to the provisions set forth in the body of this order.
- 2. On October 7, 2010, at 8:30 a.m., the arbitrator will convene an evidentiary hearing on the merits of the unresolved issues. The hearing will be in Room 305, Governor Office Building, 200 Madison Street, Jefferson City, MO 65201. The Commission has scheduled one day for the hearing.
