
1. The Company has main offices in Missouri located at 116 E. Arrow, Marshall, Missouri 65340.

(2) A list of political subdivisions to be served by the Company is accurately set forth in the application to which this affidavit is attached.



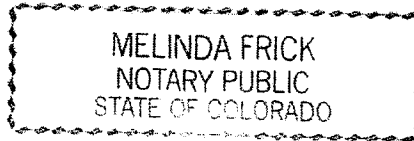

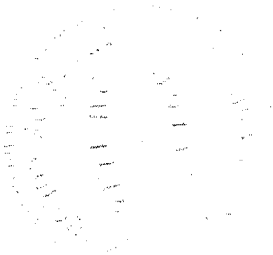
