MOTION TO MODIFY PROCEDURAL SCHEDULE

COMES NOW Southwestern Bell Telephone Company (SWBT), and for its Motion to Modify Procedural Schedule, states to the Missouri Public Service Commission (Commission) as follows:

- 1. The current procedural schedule in these consolidated cases provides that SWBT shall file Rebuttal Testimony no later than 3:00 p.m. on Monday, May 29, 2000. However, when the parties agreed to and proposed this date to the Commission, they inadvertently did not realize it was a legal holiday, Memorial Day.
- 2. SWBT respectfully requests that the Commission modify the procedural schedule to provide that SWBT's Rebuttal Testimony shall be filed no later than 3:00 p.m. on Wednesday, May 31, 2000 (two days later than the current date).
