**MOTION TO MODIFY PROCEDURAL SCHEDULE**

COMES NOW Southwestern Bell Telephone Company (SWBT), and for its Motion to Modify Procedural Schedule, states to the Missouri Public Service Commission (Commission) as follows:

1. The current procedural schedule in these consolidated cases provides that SWBT shall file Rebuttal Testimony no later than 3:00 p.m. on Monday, May 29, 2000. However, when the parties agreed to and proposed this date to the Commission, they inadvertently did not realize it was a legal holiday, Memorial Day.
2. SWBT respectfully requests that the Commission modify the procedural schedule to provide that SWBT's Rebuttal Testimony shall be filed no later than 3:00 p.m. on Wednesday, May 31, 2000 (two days later than the current date).
3. Counsel for SWBT has discussed this matter with Complainants' counsel, and Complainants' counsel agrees that the procedural schedule may be modified to provide that SWBT's Rebuttal Testimony shall be filed no later than 3:00 p.m. on Wednesday, May 31, 2000.
