NOTICE OF TERMINATION OF SERVICE


COMES NOW Missouri Gas Energy (MGE), a division of Southern Union Company, and, as its Notice of Termination of Service, states as follows to the Missouri Public Service Commission (Commission):

1. On July 24, 2009 the Commission issued its Order Approving Three-Month Extension of Time to Replace Mains and Service Lines at Malang Mobile Home Park (Order).
2. The Order noted that a master metered mobile home park is one in which MGE has a master meter on the property, but the distribution lines behind the meter and the meters for the individual lots are owned by the property owner. Regulations required MGE to replace the pipe behind the meter in these mobile home park distribution systems, while billing the mobile home park owner for a part of the cost of doing so.
3. The Order deferred MGE's obligation to replace the mains and service lines for the Malang Mobile Home Park (f/k/a Heistland Mobile Home Park) from June 30, 2009, to September 30, 2009. The Order further provided that MGE should cease providing natural gas service to Malang Mobile Home Park on September 30, 2009, if the required service line replacement has not been completed at that time.
4. The owner of the Malang Mobile Home Park was unwilling to participate in the identified replacement process. Accordingly, MGE terminated natural gas service to the Malang Park on September 30, 2009.

5. MGE further notes that all sixteen mobile home parks originally identified in this case have now been addressed and no further action in this case should be necessary.

WHEREFORE, MGE respectfully requests that the Commission take note of the information provided herein and issue such orders as it shall find to be reasonable and just.
