**KANSAS CITY POWER & LIGHT COMPANY AND
KCP&L GREATER MISSOURI OPERATIONS COMPANY’S
RESPONSE TO ORDER ESTABLISHING TIME TO RESPOND TO MOTION TO
DELAY THE DATE FOR STAFF TO FILE PROPOSED RULE LANGUAGE**

COME NOW, Kansas City Power & Light Company (“KCP&L”) and KCP&L Greater Missouri Operations Company (“GMO”) (collectively, the “Companies”) and for their Response to the Commission’s May 5, 2013 Order Establishing Time to Respond to Motion to Delay the Date for Staff to File Proposed Rule Language (“Order”), hereby state as follows:

1. On May 5, 2014, Ameren Missouri filed a Response to Staff Motion for Commission Order Directing Responses and Scheduling a Workshop (“Response”). Ameren Missouri requested that the August 29, 2014 deadline under which the Staff is now operating be moved to December 19, 2014 so as to afford the Staff and interested stakeholders sufficient time and flexibility to engage in the workshop process in a more meaningful and hopefully productive way.

2. The Companies support Ameren Missouri’s request for a December 19, 2014 Staff Recommendation deadline in this docket. The issues raised by Staff’s questions are novel and complex and the Companies do not believe that there must be a resolution of these issues in the next three months. Giving all parties more time to formulate responses and conduct research on Staff’s questions will ensure that all policy considerations are fully developed in the workshop.

WHEREFORE, KCP&L and GMO respectfully request that the Commission consider this Response and adopt the December 19, 2014 deadline recommended by Ameren Missouri.
