#### ORDER APPROVING INTERCONNECTION AGREEMENT

Issue Date: November 16, 2021 Effective Date: December 16, 2021

This order approves an Interconnection Agreement between the parties filed by Citizens Telephone Company of Higginsville, Missouri, Inc. (Citizens Telephone Company).

On October 13, 2021, Citizens Telephone Company filed an application with the Commission for approval of an Interconnection Agreement between itself and Charter Fiberlink-Missouri, LLC under the provisions of the Federal Telecommunications Act of 1996. Citizens Telephone Company is certificated with the Commission as an incumbent local exchange carrier. Charter Fiberlink-Missouri, LLC is an interexchange and a competitive local exchange carrier.

Although Charter Fiberlink-Missouri, LLC is a party to the Agreement, it did not join in the application. On October 20, 2021, the Commission issued an order making Charter Fiberlink-Missouri, LLC a party in this case and directing any party wishing to request a hearing to do so no later than November 5, 2021. No requests for hearing were filed.

Under Section 252(e) of the Act, any Interconnection Agreement adopted by negotiation must be submitted to the Commission for approval. The Commission may reject an Agreement if it finds that the Agreement is discriminatory or that it is not consistent with the public interest, convenience and necessity.

On November 15, 2021, the Staff of the Commission filed a recommendation. Staff recommends that the Agreement be approved and notes that the Agreement meets the limited requirements of the Act in that it is not discriminatory toward nonparties and is not against the public interest.

The Commission has considered the application, the supporting documentation, and Staff's recommendation. Based upon that review, the Commission finds that the Agreement meets the requirements of the Act in that it does not discriminate against a nonparty carrier and implementation of the Agreement is not inconsistent with the public interest, convenience and necessity.

#### THE COMMISSION ORDERS THAT:

- The Interconnection Agreement between Citizens Telephone Company and Charter Fiberlink-Missouri, LLC, filed on October 13, 2021, is approved.
  - 2. This order shall become effective on December 16, 2021.
  - 3. This file may be closed on December 17, 2021.
