ORDER AND NOTICE OF HEARING

On July 17, 1978, Stoddard County Sewer Co., Inc., Highway 114 West,
Dexter, Missouri 63841, filed an application with the Commission seeking authority
to operate a sewer system as a public utility in a part of Section 32, Township
25 North, Range 16 East, in Stoddard County Missouri, known as Western Heights
Subdivision and Ecology Acres Subdivision.


The Commission is of the opinion that a hearing should be held for the
purpose of receiving evidence in support of or in opposition to the authority
sought.
