**MOTION TO WITHDRAW  
CHARTER FIBERLINK'S MOTION TO COMPEL**

---

**COMES NOW** Charter Fiberlink-Missouri, LLC ("Charter") by and through its attorneys, pursuant to 4 CSR 240-2.080, and for its Motion to Withdraw states the following to the Commission:

1. On February 12, 2008, Charter submitted its first set of data requests to CenturyTel of Missouri, LLC ("CenturyTel").
2. On February 22, 2008, CenturyTel submitted its objections to many of Charter's data requests.
3. On March 5, 2008, Charter filed a Motion to Compel CenturyTel to produce information and documents requested in Charter's first set of data requests, to which CenturyTel had objected.
4. On March 6, 2008, CenturyTel submitted responses to Charter's first set of data requests, including some responses to the data requests that CenturyTel had initially objected to.
5. Due to the very short period of time before the hearing scheduled in this proceeding, Charter has decided to withdraw its Motion to Compel in the interests of moving

towards a final resolution of disputed issues, and to avoid the possibility of delay of the resolution of such issues.

**WHEREFORE**, Charter respectfully requests the Commission grant this Motion to withdraw its previously filed Motion to Compel the production of information and documents from CenturyTel.
