ORDER SUSPENDING TARIFF SHEETS AND DIRECTING FILING

Issue Date: June 2, 2011 Effective Date: June 4, 2011

On May 4, 2011, the Commission issued its Report and Order approving certain rates for KCP&L Greater Missouri Operations Company (GMO). On May 27, 2011, the Commission issued an Order of Clarification and Modification which rejected tariffs filed in compliance with the Report and Order and required the filing of additional tariff sheets. The Commission also determined that good cause existed for the tariffs, with the exception of the fuel adjustment clause portion, to become effective on June 4, 2011, with less than thirty days' notice. Additional compliance tariffs were filed on May 31, 2011, and substitute sheets were filed on June 1, 2011.

The Staff of the Commission filed suggestions regarding the Commission's decision to make the fuel adjustment clause (FAC) portion of the tariffs effective on July 1, 2011, with the base rates tariffs becoming effective on June 4, 2011. Ag Processing, Inc. a cooperative and the Sedalia Industrial Energy Users' Association

(SIEUA) filed a response, and an additional reply was received from Staff and from GMO.

The Office of the Public Counsel objected to the tariffs. First Public Counsel objects to the shortened time for responses and states that it has not had sufficient time to review and respond to the tariffs or review the pleadings filed by Staff regarding the FAC tariffs. Public Counsel's second objection is to the interest rate of 8.414% contained as "carrying costs" for the phase-in portion of the rates. GMO indicated in its cover letter filed with the tariffs that it included its authorized rate of return (ROR) of 8.414% as a carrying cost ordered by the Commission. Ag Processing concurred in the objections of Public Counsel and further objects to the "phase-in of rates in excess of filed-for levels."

The Staff of the Commission filed a recommendation regarding the tariffs on June 2, 2011. In that recommendation, Staff recommends that the tariffs bearing a June 4, 2011 effective date and a July 1, 2011 effective date be approved as in compliance with the Commission Report and Order. In its recommendation, however, Staff had not yet had an opportunity to complete its review of the additional tariff sheets.

The Commission previously found that good cause existed to approve the tariffs on less than thirty days' notice, and specifically ordered the compliance tariffs to contain a June 4, 2011 effective date. After receiving the responses and objections, however, it is clear, that the parties have not had an opportunity to examine the tariffs thoroughly. In addition, the Commission may need to clarify its order further to be clear about what the Commission intended to be "carrying costs." For those reasons the

Commission shall suspend the tariff sheets to allow additional time for objections and to review the phase-in tariffs.

The Commission will also direct the parties to make a filing stating GMO and/or Great Plains Energy's (GPE) short-term cost of debt and any arguments why the "carrying costs" for the phased-in rates should not be equal to GMO or GPE's short-term cost of debt.
