

In the matter of the application of
WILLIAM E. EVANS and LORAIN E. EVANS
for permission, approval and certificate
of convenience and necessity authorizing
them to construct, install, own, operate,
control, manage and maintain a water
system for the public located in an
unincorporated area in Henry County,
Missouri.

ORDER AND NOTICE OF DISMISSAL

At the time set for hearing in this matter, on October 17, 1978, counsel
for the Applicants, Commission Staff and potential witnesses in opposition discussed
the possibility of serving the best interests of all concerned by conveying the
water system in question to an association of homeowners for its future operation.

On December 15, 1978, the Commission received notification from the
attorney for the Applicants, who is also a resident of the proposed service area,
that a homeowners association has now been formed under the not for profit pro-
visions of the statutes of the State of Missouri, and that a transfer of the water
system operated by Mr. and Mrs. Evans to the homeowners association has been
arranged.

The communication also seeks a dismissal of the case.

The Commission is of the opinion that the request to dismiss is reason-
able and proper and should be granted.

It is, therefore,

ORDERED: 1. That the application of William E. Evans and Loraine E.
Evans pending before this Commission in Case No. WA-79-16 be, and the same is,
hereby dismissed, and that the hearing presently set in this matter for the 17th day
of January, 1979, be, and is, hereby canceled.

ORDERED: 2. That this order shall become effective on the 3rd day of
January, 1979.


