Re: Request Regarding the Name Change of Onvoy, Inc. d/b/a Onvoy Voice Services to Onvoy, LLC

Dear Mr. Woodruff:

Onvoy, LLC (formerly known as Onvoy, Inc. d/b/a Onvoy Voice Services) (the "Company"), pursuant to 4 CSR 240-2.062, respectfully requests that the Missouri Public Service Commission ("Commission") change the name on the Company's certificate from Onvoy, Inc. d/b/a Onvoy Voice Services to Onvoy, LLC.

The change in the Company's name resulted from its conversion from a Minnesota corporation to a Minnesota limited liability company. The conversion was merely a change in corporate form accomplished by the filing of Articles of Conversion in Minnesota and did not entail any merger or other transactions that extinguish the existence of the Company. As a result, the customers of the Company continue to be served by the same entity from whom they previously obtained service and continue to receive invoices for services from "Onvoy" (before and after the conversion, Onvoy's invoices use the same logo as used on the letterhead for this letter) under the same rates, terms and conditions of service as before the changes. Therefore, notice to customers of the change in name is not necessary.

A copy of the Company's Articles of Conversion and updated authority to transact business from the Missouri Secretary of State reflecting the Company's new name is provided as <u>Exhibit A</u>. An adoption notice and revised tariff title sheet with the Company's new name is attached hereto as <u>Exhibit B</u>.

The Company will review contacts in EFIS for its prior name and make sure they are updated and also insert the contact information for its new name as necessary.

The Company is authorized to provide interexchange services pursuant to a certificate of authority issued by the Commission in Case No. TA-97-216 on January 28, 1997.


