Intrado Communications Inc. (the “Company”) hereby notifies the Commission that it has changed its name to West Safety Communications Inc. The Company respectfully requests that the Commission issue an updated certificate, if applicable, to reflect the Company’s name as “West Safety Communications Inc.” The Company is authorized to provide basic local exchange and interexchange telecommunications services in Missouri pursuant to authority granted in Case No. TA-2002-154 and File No. CA-2011-0360.

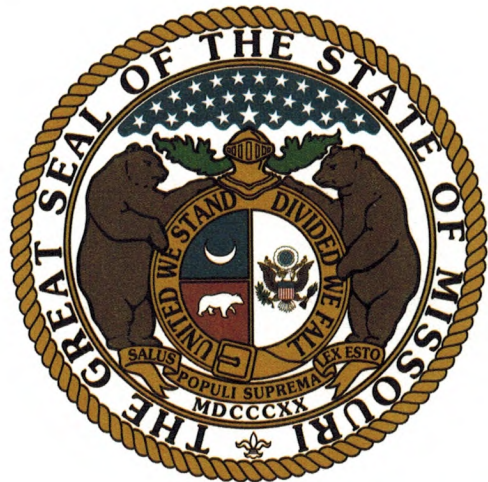
