## **APPLICATION FOR REHEARING**

COMES NOW the Office of the Public Counsel and for its Application for Rehearing states as follows:

1. On December 12, 2012, the Commission issued its Report and Order with an effective date of December 22, 2012. The Report and Order is unjust, unreasonable, arbitrary and capricious, and unlawful for the following reasons.

2. The Commission erred by permitting Union Electric Company d/b/a Ameren Missouri to flow Midwest Independent System Operator (MISO) transmission charges, which include charges reflecting various costs of building transmission facilities that are not used and useful at the time of flow-through, through the Fuel Adjustment Clause (FAC). The MISO charges include costs associated with electric plant that will not have been placed in service at the time the charges flow through the FAC in violation of Section 393.135 RSMo 2000. The MISO charges are not allowed in the FAC pursuant to Section 386.266.1, RSMo 2000 because they are not "prudently incurred fuel and purchased-power costs, including transportation."

3. The Commission erred in not addressing the sworn and competent testimony adduced at the local public hearings. Nowhere in the Report and Order does the Commission find the testimony of any witness at the local public hearings to be not credible and the witnesses were not impeached, but yet the Report and Order fails to take any of that testimony into account. It also failed to address the testimony of Public Counsel witness Barbara Meisenheimer, who was the only witness in the case that proposed a way of addressing the testimony adduced at the public hearings. Ms. Meisenheimer testified that the way to address the testimony taken at local public hearings would have been to adopt a return on equity at the bottom end of the range that the Commission found reasonable. The Commission ignored that proposal and ignored the testimony of dozens of witnesses. An administrative tribunal may not arbitrarily disregard or ignore undisputed testimony of a witness not shown to have been impeached or disbelieved by the administrative tribunal.<sup>1</sup>

WHEREFORE Public Counsel respectfully requests that the Commission grant rehearing of its December 12, 2012 Report and Order.
