SECOND MOTION FOR EXTENSION OF TIME TO FILE PROPOSED PROCEDURAL SCHEDULE

COMES NOW the Staff of the Missouri Public Service Commission, on its own behalf and on behalf of Missouri-American Water Company, the Office of the Public Counsel, and the Platte County Regional Sewer District, being all of the parties in this case, and, for its Second Motion for Extension of Time to File Proposed Procedural Schedule, states to the Missouri Public Service Commission as follows.

On May 15, 2007, the Commission issued an order scheduling a procedural conference of all parties for May 30, 2007. In the same order, the Commission ordered the parties to jointly or separately file a proposed procedural schedule no later than June 6, 2007. On June 6, 2007, the Staff, on behalf of all parties, filed a motion to extend the deadline for filing the procedural schedule, so they could verify certain important new information that may have a significant bearing on the procedure to follow in the case. The Commission granted that motion on June 7, 2007, and extended the deadline for filing the proposed procedural schedule to June 15, 2007.

The parties' diligent efforts to verify the information that they referred to in the previous Motion for Extension have not been successful, because the parties have not been able to contact the witness who can verify the said information.

The parties therefore request another extension of the time by which they must file a proposed procedural schedule, in order to enable them to complete the necessary investigation. The parties believe that ten days will be a sufficient amount of time to verify this information, and they request that the deadline for filing the proposed procedural schedule be extended to June 25, 2007.

WHEREFORE, the parties move the Commission for its order extending the deadline for filing a proposed procedural schedule to June 25, 2007.
