**PROPOSED PROCEDURAL SCHEDULE**

**COMES NOW** the Director of the Manufactured Housing and Modular Units Program of the Public Service Commission (“Director” and “Department”), by and through the Missouri Public Service Commission’s (“Commission”) Office of General Counsel, and for its Proposed Procedural Schedule states as follows:

1. On May 25, 2006, the Commission held a prehearing conference in the above-captioned case pursuant to its May 18<sup>th</sup> Order Resetting Prehearing Conference. At this conference, counsel for the Director and for Blakely Manufactured Homes (“Blakely”) (collectively the “Parties”) entered appearances and discussed possible dates for an evidentiary hearing in this matter. The Parties also discussed the steps that Blakely has taken toward achieving a possible settlement of claims by Larry and Joyce King, the owners of the modular unit home that is the subject of this case.

2. On June 26, 2006, the Commission issued its Order Directing Filing (“Order”) directing the parties to file a proposed procedural schedule including the scheduling of an

evidentiary hearing. As a result of discussions between Staff counsel and counsel for Blakely, the Parties agreed on setting the evidentiary hearing for August 8 and 9, 2006.

**WHEREFORE**, on behalf of the Parties, the Director respectfully requests that the Commission set this case for evidentiary hearing on August 8 and 9, 2006.
