MOTION TO REVOKE REGISTRATION

COMES NOW the Staff of the Missouri Public Service Commission ("Staff"), by and through the undersigned counsel, and moves for the Missouri Public Service Commission ("Commission") to revoke the registration of Ojo Service LLC d/b/a WorldGate ("WorldGate" or "Company") to provide Interconnected Voice over Internet Protocol service in the state of Missouri. For its Motion, Staff respectfully states as follows:

1. On April 28, 2010, WorldGate filed an Application before the Commission requesting registration to provide Interconnected Voice over Internet Protocol services in certain exchanges in the state of Missouri in Case No. DA-2010-0301.
2. Section 392.550.3 (7), RSMo (Supp. 2010) requires that an Applicant affirm that it "...will file...with the commission an annual report at a time and covering the yearly period fixed by the commission."
3. On May 28, 2010, the Commission granted WorldGate authority to provide Interconnected Voice over Internet Protocol services in certain exchanges in the state of Missouri.
4. WorldGate is delinquent in the filing of its 2010 and 2011 calendar year annual reports. The Company has not responded to written and telephone

correspondence concerning this matter. Electronic correspondence to the Company's on-file email address was returned as undeliverable.

5. Section 392.550.4 (6), RSMo (Supp. 2010) states the Commission shall have the authority "[t]o revoke or suspend the registration of any provider of interconnected voice over Internet protocol service who fails to comply with the requirements of this section."

6. Staff requests the Commission revoke WorldGate's registration due to its failure to file annual reports each calendar year since the Commission granted registration.

7. The Commission need not hold a hearing, if, after proper notice and opportunity to intervene, no party requests such a hearing. *State ex rel. Rex Deffenderfer Enterprises, Inc. v. Public Service Commission*, 776 S.W.2d 494 (Mo. App. W.D. 1989).

WHEREFORE, Staff recommends the Commission revoke the registration of Ojo Service LLC d/b/a WorldGate to provide Interconnected Voice over Internet Protocol service in the state of Missouri.
