### MOTION TO STAY ORDER

("UAT"), by and through the undersigned counsel, and moves for the Missouri Public Service Commission ("Commission") to stay the Commission's February 13, 2014 *Order Canceling Certificate And Accompanying Tariff*. In support of its Motion, UAT respectfully states as follows:

- 1. On February 13, 2014, the Commission issued its *Order Canceling Certificate And Accompanying Tariff* ("*Order*") cancelling UAT's certificate of service authority to provide switched interexchange and non-switched local exchange telecommunications services in the state of Missouri, effective February 25, 2014.
- 2. On February 20, 2014, a representative of UAT contacted Oklahoma based counsel, identified below, to express UAT's desire to retain its certificate of service authority and its tariff, P.S.C. MO No. 1.
- 3. UAT has completed, or is in the process of completing, the submission of all outstanding annual reports as required by Commission rules. Also, UAT either has or soon will have paid all outstanding universal service fund fees. As such, UAT will have cured all events of default, delinquency and/or deficiencies that resulted in the Commission's *Order*. Commission Staff's review of the annual report filings is pending.

4. UAT seeks to stay the Commission's *Order* to allow Staff time to review the recent submissions by UAT and find UAT in compliance with Commission rules.

**WHEREFORE**, United American Technology, Inc. moves that the Commission stay its February 13, 2014 *Order Canceling Certificate And Accompanying Tariff*.
