MOTION TO ACCEPT LATE-FILING

Comes now Sprint Spectrum L.P. d/b/a Sprint PCS and seeks permission from the Commission to late-file its Reply Brief in the above entitled case. In support Sprint PCS states as follows:

1. At the time of the hearing the parties agreed to a briefing schedule of December 10, 1999 for Initial Briefs and January 10, 2000 for Reply Briefs. (T. at 439)
2. Thereafter the Commission entered an Order adopting a briefing schedule that set the Reply Brief date on January 4, 2000, instead of the January 10, 2000 date originally proposed by the parties at the hearing.
3. The files of the under-signed counsel do not reflect receipt of that order. At this point, it is not known whether the Order was never received or if it was misplaced after receipt. In either case, counsel was unaware that the Reply Brief filing date had been changed until January 6, 2000 while attending a pre-hearing on another matter.
4. Upon return to the office, this motion was immediately prepared and the brief filed. No party should be prejudiced by the late-filing. All counsel of record have been served with the Reply Brief and this Motion via facsimile on this date.
