This comes in response to your April 19, 2004 letter requesting service of process for K.C. Fibernet.

In the documents you enclosed with your letter, you reference section 351.380.1, RSMo 2000, which provides that if a corporation fails to maintain a registered agent in Missouri, then the Secretary of State, as long as such default exists, shall be automatically appointed as an agent of such corporation upon whom any process, notice or demand required or permitted by law to be served upon the corporation may be served. Our records show that K.C. Fibernet is a fictitious name registration. A fictitious name registration is not necessarily a corporation. In order to determine whether K.C. Fibernet is a corporation, please provide the legal name of K.C. Fibernet, as well as the address that you wish us to forward the documents for service.

As soon as we receive the additional information, we can determine the appropriate action. Thank you for your attention to this matter.
