Although the Regulatory Law Judge stated during the prehearing conference held on January 3, 2003, that all applicants would be granted the right to intervene (Tr. 4), the Order Granting Intervention and Directing Filing did not specifically list KCPL among the parties granted intervention. KCPL would respectfully request that its status as an intervenor in this matter be clarified, and/or granted.
- 3. For its status report, KCPL states that its participation in this case has been limited to monitoring the developments in the case and KCPL has not taken an active role to date.
