### **MOTION FOR LEAVE TO AMEND APPLICATION**

COMES NOW **True Wireless, LLC** (“True Wireless”), pursuant to 4 CSR 240-2.080(20), and moves for leave to amend its application in the above-referenced matter. In support thereof, True Wireless submits the following:

1. True Wireless filed its application for Designation as an Eligible Telecommunications Carrier Pursuant to 47 U.S.C. § 214(e) on February 18, 2011.
2. In its application, True Wireless seeks to be designated as an Eligible Telecommunications Carrier in the exchanges of Southwestern Bell and CenturyTel of Missouri.
3. True Wireless now seeks to amend Exhibit A, which contains the list of wire centers in which it will offer service, by specifying the wire centers by CLLI code only and not by ratecenters.
