## MOTION FOR EXPEDITED CONSIDERATION AND APPROVAL OF TARIFF SHEET FILED IN COMPLIANCE WITH COMMISSION ORDER ON LESS THAN THIRTY DAYS' NOTICE

COMES NOW Kansas City Power & Light Company ("KCP&L") and for its Motion for Expedited Consideration and Approval of Tariff Sheets Filed in Compliance with Commission Order on Less than Thirty Days' Notice respectfully states as follows to the Missouri Public Service Commission ("Commission"):

- 1. On April 12, 2011, the Commission issued its *Report and Order* herein, authorizing KCP&L to increase its annual revenues by approximately \$34.8 million. Among other things, the *Report and Order* directs KCP&L to file by April 18, 2011, revised tariff sheets that comport with the *Report and Order*. (*Report and Order*, Ordered Paragraph 3, p. 182)
- 2. KCP&L respectfully requests expedited approval of P.S.C. MO. No. 7, Tariff Sheet No. 47. Specifically, KCP&L requests an effective date of May 4, 2011 as contemplated in the *Report and Order* and requested in the application that initiated this proceeding. Section 393.140(11) provides that "The commission for good cause shown may allow changes without requiring the thirty days' notice under such conditions as it may prescribe." To show good cause for approval of the revised tariff sheets to be effective for electric service rendered on and after May 4, 2011, KCP&L states that the tariff sheets have been filed in compliance with

the Commission's Report and Order herein.

3. P.S.C. MO. No. 7, Tariff Sheet No. 47 references the Stipulation and Agreement

approved by the Commission regarding Outdoor Lighting Issues. KCP&L, Office of Public

Counsel and Robert Wagner agree that P.S.C. MO. No. 7, Tariff Sheet No. 47 reflects their

agreement. Staff is not opposed to P.S.C. MO. No. 7, Tariff Sheet No. 47. There will be no

negative effect on KCP&L's customers or the general public if the Commission grants this

motion and approves the tariff sheet to be effective on May 4, 2011.

4. KCP&L requests approval of the revised tariff sheets to be effective on May 4,

2011, as this would be consistent with the requirements of the law and long-standing

Commission custom, practice and precedent.

WHEREFORE, KCP&L respectfully requests that the Commission grant the Motion for

Expedited Consideration and Approval of P.S.C. MO. No. 7, Tariff Sheet No. 47 Filed in

Compliance with Commission Order on Less than Thirty Days' Notice and approve the tariff

sheet KCP&L has filed on April 26, 2011 to be effective for service rendered on and after May

4, 2011.
