
MOTION FOR CORRECTION

Comes now the Small Telephone Company Group (STCG) and for its Motion for
Correction states to the Missouri Public Service Commission (Commission) as follows:

1. On September 9, 1998, the Commission issued its Order Granting Interventions
and Setting Early Prehearing Conference in the above-referenced matter. At page 4 of the Order,
the Commission references the fact that the Small Telephone Company Group filed an
Application to Participate Without Intervention on August 26, 1998. The Commission then goes
on to list, in its footnote No. 3, the participants of the STCG including, among others, the New
London Telephone Company. A review of the STCG's Application reveals that the New London
Telephone Company was not included in the STCG for purposes of its participation in this case.

WHEREFORE, the STCG respectfully requests the Commission issue its order correcting
its Order Granting Interventions and Setting Early Prehearing Conference, footnote No. 3, to
reflect the fact that the New London Telephone Company is not part of the STCG for purposes of
its participation in this case.


