**MOTION FOR EXTENSION OF TIME  
TO FILE PROPOSED PROCEDURAL SCHEDULE**

**COMES NOW** the Staff of the Missouri Public Service Commission, by and through counsel, and for its *Motion for Extension of Time to File Proposed Procedural Schedule* in this case hereby respectfully states:

1. As ordered by the Commission, the parties to this case—Staff, Laclede Gas Company d/b/a Missouri Gas Energy (“Laclede”), Southern Union Company (“Southern Union”), and the Office of The Public Counsel (“Public Counsel”)—attended a procedural conference in this case on May 2, 2014.
  
2. At the procedural conference, the presiding regulatory law judge in this case ordered the parties to file a joint recommended procedural schedule, or to file competing recommendations, no later than May 9, 2014.

3. The parties have discussed procedural issues, and need additional time for further discussion.<sup>1</sup> Therefore, Staff hereby requests an extension of time to file either a joint recommended procedure schedule or competing schedules no later than Friday, May 16, 2014.

4. Staff has discussed this motion with the other parties to this case, and all parties have indicated they will not oppose this motion for extension of time.

**WHEREFORE**, Staff respectfully requests the Commission issue an order instructing the parties to file a joint proposed procedural schedule, or competing proposed procedural schedules, no later than May 16, 2014.
