# <u>CENTURYTEL OF MISSOURI, LLC'S MOTION</u> <u>FOR LEAVE TO CORRECT TESTIMONY</u>

COMES NOW CenturyTel of Missouri, LLC ("CenturyTel") and, pursuant to Commission Rule 4 CSR 240-2.130, moves for leave to file the attached Errata correcting Page 18 of the Prefiled Direct Testimony of CenturyTel Witness Guy E. Miller, III. In support of its motion, CenturyTel respectfully states as follows:

1. On September 30, 2008, pursuant to the Commission's adopted schedule, CenturyTel filed the direct testimony of its witnesses in this matter, including the Direct Testimony of Guy E. Miller, III.

2. Subsequent to the filing date, CenturyTel identified the need for minor correction to Mr. Miller's testimony at Page 18, lines 12-13, by deleting certain words and commas in his answer, so that the phrase in subpart (4) (appearing at lines 10-14) should now read as follows: "(4) Charter must obtain CenturyTel's authorization and must compensate CenturyTel for access to the "customer access side" of the NID to house Charter's interconnection with its customer's Inside Wire or otherwise to occupy CenturyTel's NIDs with facilities owned by Charter and/or its customer."

3. The attached Errata reflects the new Page 18 containing the abovedescribed corrections to Mr. Miller's Direct Testimony, which CenturyTel requests be substituted in the Prefiled Direct Testimony of Guy E. Miller, III, previously filed in this matter on September 30, 2008.

4. CenturyTel wishes to make the above corrections prior to the scheduled date for filing Rebuttal Testimony in this matter, October 21, 2008. Accordingly, CenturyTel does not believe that any party will be prejudiced by its requested relief.

WHEREFORE, for the foregoing reasons, CenturyTel of Missouri, LLC respectfully requests that the Commission issue its Order granting CenturyTel leave to file the described corrected page to the Direct Testimony of Guy E. Miller, III and recognizing the filing of the same, and for such other and further relief as the Commission deems just and proper.
