**MOTION TO OPEN CASE AND CANCEL CERTIFICATE OF SERVICE
AUTHORITY AND ACCOMPANYING TARIFF**

COMES NOW the Staff of the Missouri Public Service Commission (Staff) and for its Motion to Open Case and Cancel Certificate of Service Authority and Accompanying Tariff, respectfully states as follows:

1. On March 25, 1997, the Missouri Public Service Commission (Commission) granted a certificate of service authority to provide intrastate interexchange telecommunications services to Global Telephone Corporation (Global) in Case No. TA-97-322.

2. A letter addressed to the Commission by Technologies Management, Inc., attached hereto as Exhibit A, states that Global "filed a Chapter 11 proceeding on December 21, 1998 which was converted to a Chapter 7 proceeding on October 20, 2000." Counsel for Staff contacted the trustee of the bankruptcy, Kathleen P. Dwyer. Mrs. Dwyer did not think that Global had any customers in Missouri. Mrs. Dwyer is included in the service list for this filing.

3. Global has not filed a formal request to cancel its certificates. However, the Commission has the authority to cancel a telecommunications corporation certificate pursuant to Section 392.410.5 RSMo 2000, which provides:

Any certificate of service authority may be altered or modified by the


commission after notice and hearing, upon its own motion or upon application of the person or company affected.

5. The Commission need not hold a hearing, if, after proper notice and opportunity to intervene, no party requests such a hearing. State ex rel. Rex Deffenderfer Enterprises, Inc. v. Public Service Commission, 776 S.W.2d 494 (Mo. App. 1989).

WHEREFORE, the Staff recommends the Commission cancel the certificate of service authority to provide interexchange services and any accompanying tariffs of Global Telephone Corporation.


Technologies Management, Inc. would like to inform the Commission that it no longer represents Global Telephone Corp. in any capacity relating to the regulatory matters of the company.
