COMES NOW the Office of the Public Counsel and states that it supports the position taken by Staff in response to PSC Question #3 regarding adopting a hybrid protective order as proposed in this case for all PSC cases. The PSC should not make a major change in the scope of the standard protective order without (1) adequate prior notice to affected parties that appear and practice before the PSC (2) without an opportunity to receive input on the proposed changes from parties that appear before the PSC and the public. Therefore, a rulemaking proceeding as recommended by the Staff is preferable to an order changing the standard protective order for all future cases coming out of this case.
