2. The Weiss testimony raises issues with respect to data requests and information about transmission charges billed from Ameren Energy to Union Electric Company not previously raised by UE.

3. On July 2, 2002, Public Counsel faxed to UE data requests 4063 through 4065 seeking information regarding the claims made in witness Weiss's cross-surrebuttal testimony. (A copy of the data requests are attached.).

4. Because of the pendency of the hearing, Public Counsel requests that UE be directed to respond to Public Counsel data requests 4063 through 4065 no later than 10 days from July 2, 2002. Thus by July 12, 2002.

5. Public Counsel witness Effron is scheduled to testify on July 18, 2002. (Proposed List of Issues Order of Witnesses and Order of Cross-Examination, p. 14, filed June 28, 2002).

6. Due to the pendency of the hearing good cause exists to expedite the answers to data requests 4063 through 4065.

7. Public Counsel requests the Commission order UE to respond to this request within five days.

WHEREFORE: Public Counsel requests the Commission shorten UE's time to respond to Public Counsel's data requests 4063 through 4065 from 20 days to 10 days.


