This filing is submitted on behalf Cincinnati Bell Any Distance Inc. ("CBAD" or "Company") to request approval from the Commission of a change in the Company name to CBTS Technology Solutions LLC. CBAD received a certificate of service authority to provide intrastate interexchange telecommunication services in Missouri in Case No. XA-2004-0269, Tariff File No. YX-2004-0876 on February 6, 2004 and a certificate of service authority to provide basic local and non-switched local exchange telecommunications services in Missouri in File No. CA-2010-0098, effective October 29, 2009.

Through a series of Delaware and Missouri Secretary of State transactions, copies which are attached as Exhibit A, effective September 29, 2017, CBTS Technology Solutions LLC filed, and the Missouri Secretary of State approved, an Application for Registration of a Foreign Limited Liability Company. Thereafter, as required by law, the company filed a Request for Tax Clearance with the Missouri Department of Revenue, under the name then appearing on the Department's record, Cincinnati Bell Any Distance Inc. On October 31, 2017, the Missouri Department of Revenue issued the requested Tax Clearance Certificate. Effective November 1, 2017, CBTS Technology Solutions Inc. filed, and the Missouri Secretary of State approved, an Application for Certificate of Withdrawal, again under its registered name, Cincinnati Bell Any Distance Inc. As a result of these filings, the Missouri Secretary of State issued a Certificate of Registration for CBTS Technology Solutions LLC and a Certificate of Withdrawal for Cincinnati Bell Any Distance Inc., and also issued the company a new charter number, FL001421571, to replace the number under which Cincinnati Bell Any Distance Inc. had been registered, F00378717. An Adoption Notice for the Company's P.S.C. MO Interexchange Telecommunications Tariff No. 1 is attached along with the Adoption Notice for the Company's P.S.C. MO Local Services Tariff No. 2 as Exhibit B.

The name change and change in form will have no customer impact. A customer notice in the form of a bill message is being provided to all customers stating: "Cincinnati Bell Any Distance Inc. has converted to a limited liability company and changed its name to CBTS Technology Solutions LLC. This change has been processed by the appropriate authority(ies) in your state. Effective January 1, 2018, you will see this name change reflected on your bills. This change does not affect your service or rates, including any of your rights or obligations."
